

Poetry in General explores how poets expanded their practice into the realms of politics, work, and everyday life from 1960 to the present, from the apex of the welfare state to an era of privatization and austerity. It considers a compelling array of figures - including Yoko Ono, George Brecht, Frank O'Hara, Amiri Baraka, Bernadette Mayer, Eleanor Antin, Adrian Piper, and NourbeSe Philip - whose works draw on conceptual techniques to transform official documents and spaces. Finberg shows how these public texts expose the mechanisms of the neoliberal consensus about work and leisure, the state's facilitation of capitalism, and enduring racial and gender inequities.



Edward Mendelson explores the novel's deepest questions, focusing on the core themes of medicine, empire, and love. He traces how Virginia Woolf thought and wrote, considering the complexities and resonances of her works. Mendelson casts Mrs. Dalloway as an extended protest against authorities that wield power over others and a defense of the equality of inner lives. He also examines the place of the book in literary history going back to Homer, Dante, and Shakespeare as well as its influence on later writers from Erich Auerbach through Zadie Smith.

Chinese Songs in a French Key tells the extraordinary story of the birth, rebirth, and rich afterlife of The Book of Jade. Pauline Yu traces the research and creative process behind the book, including Gautier's collaboration with a Chinese refugee known as Tin-Tun-Ling. She

shows, through juxtapositions with original Chinese texts, how Gautier's imaginative strategies conveyed core elements of Chinese poetry to a European audience. Yu explores how the work's influence reverberated across French letters, Anglo-American modernist poetry, and the international history of translation. The story also unfolds within Gautier's network of luminaries?such as Victor Hugo, Richard Wagner, and John Singer Sargent?and against the backdrop of France's "discovery" of China through scholarship and plunder. Drawing attention to Gautier's audacity and accomplishments, this deeply researched and elegantly written book provides new perspectives on the surprising routes cultural transmission can take.



By showing how writers in North and South Korea engaged in dialogue via the mediation of a multiethnic set of colleagues in Japan, *Triangle Republics* offers a new perspective on this era, emphasizing its vibrant, dynamic, and interconnected nature.



Mystical and benevolent, the colossal lepidopteran Mothra has been one of the most beloved kaiju since 1961, when *The Luminous Fairies* and *Mothra* was originally published in Japanese. Commissioned by Tōhō Studios from three of Japan's most prominent postwar literary writers (Shin'ichirō Nakamura, Takehiko Fukunaga, and Yoshie Hotta), the novella formed the basis for the now-classic monster film *Mothra*, with a protagonist second only to Godzilla in number of film appearances by a kaiju. Finally available in its first official English translation, *The Luminous Fairies and Mothra* will captivate ardent, longtime fans of the films as well as newcomers.



Today that consensus has shattered, replaced by a "new economic nationalism" of industrial policy, tariffs, and various methods of state support for the economy. Can this new approach deliver stability, national security, and prosperity? This book examines case studies revealing a decidedly mixed record. In some instances, economic nationalist policies have fostered growth and declining unemployment,

though accompanied by fiscal costs and inefficiency. In much of the developing world, however, economic nationalist policies have produced corruption, debt burdens, inflation, and ultimately stagnation. By examining the past, *The New Economic Nationalism* provides a roadmap to an uncertain future.



To Protect Their Interests is a groundbreaking historical account of how corporate bankruptcy became what it is today - a forum for battles between well-heeled insiders. Stephen J. Lubben strips away the myths surrounding the history of corporate restructuring, showing that it emerged a decade before Morgan, when the robber baron Jay Gould strove to keep control of his railroad by working out a compromise with a handful of wealthy investors. The 1885 restructuring of Texas and Pacific Railway set the pattern for future corporate reorganizations: insider

dealing, elite manipulation of the legal system, and judicial deference. Lubben traces the evolution of the bankruptcy system through a series of major cases involving companies such as W. T. Grant and Toys "R" Us, demonstrating that it has always been a way for the powerful to maintain power.

It shapes how organizations recruit, evaluate, and promote, promising a fair system where the best rise to the top. But meritocracy has increasingly come under criticism for deepening inequality and reinforcing bias. How did a once-progressive ideal meant to level the playing field end up contributing to unfairness and privilege? What happens when organizations treat merit as their guiding principle without questioning how it's defined or applied? Most importantly, how can today's leaders recognize and fix what's gone wrong?



This provocative book uncovers a paradox at the heart of the 1960s: how political disillusionment became the basis for a new form of politics - a politics of the self. Examining aesthetic criticism, popular literature, avant-garde art, cinema, and political theory, Patrick Noonan argues that cultural producers in 1960s Japan cultivated what he calls an "ethos of disaffection" toward revolutionary politics and postwar society. Departing from approaches that define politics as contestation, *Age of Disaffection* foregrounds cultivation, or the production of ways of feeling

and relating to the world in efforts to redefine the political. It presents an unorthodox account of the 1960s: withdrawal from political activity developed not as the decade ended but as it was unfolding.



In a context where mechanisms for reconciliation and redress have been defined by the settler state, this book reveals how Indigenous peoples and Japanese Canadians have responded to Western liberal notions of justice, whether by challenging or

conforming to them or pursuing their own approaches. It asks: What are the links between knowledge systems and governance, between narrative tactics and political strategy?



Ranging across law, politics, science, and medicine, he examines the blurring of the distinction between social understandings of race and biological understandings of genetic variation. Because diversity has become such a central concept across domains, Kahn contends, it enables slippage between these contradictory ideas, entangling biological and social views of race. Tracing the parallel histories of the Human Genome Project, workforce diversification efforts, U. S. Supreme Court cases over affirmative action, the rise of precision medicine, and the

COVID-19 vaccine trials, among others, he shows why diversity is often deployed in ways that threaten to biologize race or undermine efforts to address racial injustice. Combining incisive critique and interdisciplinary insight, *The Uses of Diversity* offers bracing new perspective on one of today's most vexed concepts.



In the late 2000s, when the oil sands industry proposed expanding its capacity to transport fossil fuel products, an unprecedented coalition of Indigenous nations and communities, environmental non-governmental organizations, grassroots groups, and municipal governments mobilized in response. *Mega Pipelines, Mega Resistance* explores how these social movements challenged powerful corporate and

government interests and reshaped the politics of energy infrastructure. Amy Janzwood investigates campaign coalitions that were formed to oppose two mega pipeline projects: the expansion of Trans Mountain, which was ultimately completed; and Northern Gateway, which was never built. Drawing on a wide array of documents and in-depth insider interviews with oil executives, senior government officials, coalition organizers, and lawyers, she analyzes the strategic alliances and tactics that have empowered - and attempted to thwart - these movements.



It would be easy to succumb to pessimism and political apathy in the face of governing institutions that are increasingly unresponsive to calls for change and repressive in response to protest, even as they violate human rights, ignore existential climate catastrophes, and concentrate power into fewer and fewer hands. Instead, Davis finds inspiration for genuine political change through social movements that are successfully "replacing the state" and taking over the day-to-day governance of threatened places. From contesting environmental abuse

to reasserting Indigenous sovereignty, these social movements demonstrate how people can collectively wrest control over their communities from oppressive governments and manage them with a more egalitarian ethics of care.





They draw on personal recollections, interviews, and research to portray a foreign policy that was more coherent and engaged than previously believed. As arguably

Canada's first post-Cold War prime minister, Chrétien responded to events that reshaped the international landscape, notably the 9/11 attacks on the United States, the subsequent war on terror, the US-led invasion of Iraq, and Canadian involvement in Afghanistan.





Andrew L. Oros offers an expert analysis of how rapid aging and population shifts are transforming the military strategies and capabilities of regional powers in Asia. Examining sixteen states, he provides a comparative view of the developing landscape and explores ways to address the consequences. Oros demonstrates that, contrary to what many have claimed, states with shrinking populations will continue to be formidable military powers. He develops a novel theoretical and empirical argument for why rapid aging does not necessarily dampen security



competition. Nonetheless, demographic shifts in the coming decades will fundamentally alter the security challenges facing the United States and its allies. Oros considers how technological change and health care advances are mitigating the drawbacks of aging populations as well as how factors such as autonomous defense systems and artificial intelligence present new challenges.



Sasikumar Sundaram provides a bold new theory of rhetoric as power politics, demonstrating how non-Western states challenge their silencing within the Western-led international order. He argues that, in the deeply hierarchical international system, states in the lower rungs resort to rhetorical performances in order to be heard. Through anti-imperial and anticolonial rhetorical statecraft, states such as India, Brazil, and China seek to expose and exploit the contradictions in the legitimating principles, norms, and rules of the international system - and,



in so doing, pursue and exercise power. Today, as Russia, Europe, and even the United States engage in anti-imperial and anticolonial rhetoric, Sundaram shows why lessons from the non-Western world are crucial to recognizing the dynamics of power politics and global disorder. A bracing challenge to established theories of power in international relations, *Rhetorical Powers* underscores the need to address enduring forms of silencing within the international order.





Kristin Roebuck unravels the politics of sex and reproduction in Japan from the invasion of Manchuria in the 1930s to the dawn of US-Japan alliance in the 1950s, uncovering eugenic ideas and policies that policed the boundaries of kinship and country. She shows how the trauma of defeat sparked an abhorrence of interracial sex and caused a profound devolution in the social status of "mixed" children and their Japanese

mothers. She also unpacks how Japan's postwar identity crisis put pressure on the United States to bring Japanese brides and "mixed blood" children into the Cold War American family.



This interdisciplinary book provides timely fresh perspective on Palestine-Israel by rethinking the nature of settler-colonial sovereignty and the relationship between land and people. Muhannad Ayyash argues that this relationship comes in two distinct forms: a settler-colonial type, practiced by the Israeli state, that consists of "lordship" over land and people, and a decolonial type, seen in Palestinian popular organizing, that he calls "land as life," a reciprocal bond. The former is characterized by private ownership, possession, and violent expulsion of others; the latter by communal ownership, belonging to the land, and opposition to the violence of expulsion.
