Taking its title from a question in his poem "Tin Roof," Do You Want to Be Happy and Write? reassesses Ondaatje's writing and the role of the poet, from his troubled explorations of the self-reflexive artist to his most recent novels. Comprehensive in both approach and coverage, this new collection offers groundbreaking analysis informed by an understanding of Ondaatje's entire oeuvre, placing early poetry collections like The Collected Works of Billy the Kid and There's a Trick with a Knife I'm Learning to Do alongside the full range of his novels and his

extensive work as a literary editor. The book highlights the transnational, postcolonial, and diasporic issues that have become increasingly apparent in Ondaatje's work.

Music has been significant in social, religious, and political ritual, and in education, art, and entertainment in all human cultures from antiquity to today. *The Cultural History of Western Music* presents the first study of music in all its forms - ritual, classical, popular and commercial - from antiquity to today. The work is divided into 6 volumes, with each volume covering the same topics, so readers can either study a period/volume or follow a topic across history.

The topics are identity, communities and society; changing philosophies and ideas about music; politics and power; musical exchange and knowledge transfer between the West and the non-West; musical education; popular culture and musical entertainment; the places, practices, and experiences of performance; and the development of music technologies and media. The page extent for the pack is approximately 1712pp. Each volume opens with Notes on Contributors and an Introduction and concludes with Notes, Bibliography, and an Index.

Fin-de-siècle Paris, like Edo before it, saw the rise of antiestablishment attitudes and a Bohemian subculture. As artists searched for fresh and more expressive forms, Henri de Toulouse-Lautrec (1864-1901) and his contemporaries were drawn to novel Japanese prints. While ukiyo-e's formal influences on Toulouse-Lautrec and his peers have been well studied, the shared subversive hedonism that underlies these artworks has been less examined. Through a wide selection of Japanese prints and Toulouse-Lautrec works, this book offers a critical look at the renegade spirit inhabiting the graphic arts in both Edo and Paris, highlighting the social impulses behind a burgeoning art production. From uranium mines on the Navajo Nation to craters caused by nuclear testing on the Bikini and Enewetak Atolls, the production and deployment of nuclear weapon technologies have disproportionately harmed Indigenous lands. Sustained exposure to radiation from nuclear weapons and waste affects many communities from Japan to Oceania to the US West. While antinuclear activism often takes political and legal forms, artistic responses to nuclear regimes also prompt social action and resistance. Resisting the Nuclear is an interdisciplinary

edited collection featuring historians, anthropologists, artists, and activists who explore the multifaceted forms of resistance to nuclear regimes. Through a combination of interviews, scholarly essays, and discussions of contemporary art, contributors recenter the victims of nuclear technologies and demonstrate how political and artistic expression can respond to nuclear threats and effect change.



This book is for university students, with at least a mid-intermediate level of English. Each chapter covers either a particular skill (e.g. preparing a script, pronunciation, visuals, how to begin and end a presentation) or the particular purpose of a specific moment in a presentation. For example, the final slide is designed not just to conclude and thank the audience, but is an opportunity to reach out for collaborations and assistance. The aims of each part of a presentation are also highlighted by comparisons with non-academic situations where similar skills are required. The course is highly practical with screenshots from real presentations given by PhD students. It is also designed to be fun to use.



In its diversity of topics, geographic locations, and time periods, *Realisms in East Asian Performance* aims to globalize and de-center the dominant narratives surrounding realism in theater, and revise

assumptions about the spectacular and theatrical forms of Asian performance. Understanding realism as a powerful representational style, chapters collectively reevaluate acts of representation on stage not just for East Asia, but for theater and performance studies more broadly.







Based on extensive original research, it posits that East Asia experienced four waves of international change during the interwar period: the transition to the post-World War I international order; the appearance of Nationalist China and the Soviet Union as actors in East Asian international politics; the Japanese invasion of Manchuria; and Japanese implementation of the North China Buffer State Strategy.

This book provides one of the first systematic introductions to the Japanese concept of life-environmentalism, *Seikatsu-Kankyo Shugi*. This concept emerged in the 1980s as a shared research framework among Japanese social scientists studying the adverse consequences of postwar industrialization on everyday life in communities. Life-environmentalism offers a lens through which the agency of small communities in sustaining their everyday life and living environment can be understood. The book provides an overview of this approach, including



Today the UNHCR is present in more than 130 countries and takes care of some 90 million people. This book looks at how it is deployed and who its agents are. By taking the reader through the offices in charge of the Afghan refugee crisis during the 2000s, in Geneva and in Kabul, the book shows the internal functioning of this international organization. It provides analysis of Afghan refugee policies from an original position, with the author being both agency official and anthropologist, and articulates multiple levels of analysis: the micropolitics of practices as much as the institution and the multi-scalar power relations that shape its environment.

weaknesses that have turned the Canadian federation into a destination of choice for global financial crime, where its perpetrators can operate with impunity.



In Nation Branding and International Politics Christopher Browning argues that international relations should take nation branding seriously. Nation branding not only involves the issues of culture, identity, and status - which are of principal concern to IR - but it is also a different and potentially fruitful way of reconceptualizing statehood. Mobilizing work on ontological security, anxiety, status, and distinction, and grounding the analysis in a broader historical context, Browning finds that nation branding is politically significant, though not necessarily for the reasons

its advocates claim. Specifically, the book raises important questions about nation branding's influence on the constitution of national identity, the reframing of citizenship, and the topography of contemporary geopolitics.

Boyer shows how recent decades have witnessed a shift away from competition and competitive processes, toward more

bureaucratic control of public and social goods and services and more ironclad protection of state providers against contestation by potentially competitive organizations.



This is a book about the variegated frontlines of value within an uneven, but not random, geography of capitalist expansion.



Both sides champion virtuous global orders compatible with their tastes and objectives. Washington seeks to compel Moscow to abide by its rules and vice-versa.



During the early Cold War, the Central Intelligence Agency created dozens of funding fronts to support work that aligned with CIA goals, from clandestine operations and research to liberal anticommunist programs. While investigative journalists and congressional inquiries exposed many of these fronts, little is known about their daily internal workings. With a specific focus on the 1950s and 1960s Asia Foundation, *Cold War Deceptions* provides a rare view into the bureaucratic functioning of a covert operation in which most employees did not know they were



working for the CIA. Drawing on the foundation's extensive surviving archival records and thousands of pages of declassified CIA documents, David H. Price examines how the foundation, secretly created and funded by the CIA, tried to shape Asian political, economic, intellectual, and cultural developments during the early years of the Cold War.



Late Industrialization, Tradition, and Social Change in South Korea elucidates how a country can progress economically while relying on traditional social structures that usually fragment political and economic vitality. The book proposes a new framework for macro social change under late industrialization by analyzing the specific process of interactions between economic tasks and tradition through the state's mediation. Drawing on interviews with bureaucrats in the Ministry of Commerce and Industry as well as workers and others, Yong-

Chool Ha demonstrates how the state propelled industrialization by using kinship networks to channel investments and capital into *chaebŏl* corporations. What Ha calls "neofamilism" was the central force behind South Korea's economic transformation as the state used preindustrial social patterns to facilitate industrialization. Ha's account of bureaucracy, democratization, and the middle class challenges assumptions about the universal outcomes of industrialization.

In 1937, while still a student, John F. Kennedy undertook a grand tour of Europe with his close friend and traveling companion, Lem Billings. On this journey he began to keep a diary, which is reproduced here in full and provides an unadulterated account of his thoughts and feelings. Superficially, it presents a picture of two young men enjoying their summer, sightseeing, going to the movies, bars and night clubs; but behind this we find, in Kennedy's political observations and encounters, the looming shadow of Nazism. In retrospect there are blind spots and misjudgments, but also insights of great topicality, for example on populism, and propaganda and its potent effects.
