Arranged chronologically, this collection examines how ghosts represent political change in Athenian culture in three plays by Aeschylus; their function in traditional Japanese drama; the staging of the supernatural in the dramatic liturgy of the early Middle Ages; ghosts within the dramatic works of Middleton, George Peele, and Christopher Marlowe, and the technologies employed in the 18th and 19th centuries to represent the supernatural on stage.

Films like Shoplifters and After the Storm have made Kore-eda Hirokazu one of the most acclaimed auteurs working today. Critics often see Kore-eda as a director steeped in the Japanese tradition defined by Yasujirō Ozu. Marc Yamada, however, views Kore-eda's work in relation to the same socioeconomic concerns explored by other contemporary international filmmakers. Yamada reveals that a type of excess, not the minimalism associated with traditional aesthetics, defines Kore-eda's trademark humanism. This excess manifests in small moments when a desire for human connection exceeds the logic of the institutions and policies formed by the neoliberal values that have shaped modern-day Japan.

Art of Japan presents one hundred highlights of Japanese art from the collection of the Philadelphia Museum of Art, dating from the Neolithic period to today. Among them are a temple and a teahouse, acquired in 1928, each the first of its type in an American museum. The collection is also notable for tea wares, particularly ceramics produced between the sixteenth and twenty-first centuries. The Edo and Meiji periods are especially well represented by a wide range of artworks that include calligraphy, paintings, and prints by such luminaries as Hon'ami Kōetsu (1558-1637), lke Taiga (1723-1776), and Tsukioka Yoshitoshi (1839-1892).

Mimi Okabe shows how detective manga materialized in a nation undergoing a state of crisis and how the boy detective emerged as a site of national trauma to address perceived youth problems but in thematically different ways.

Through practices of subversive friendships and being there for each other, care activism acts as an extension of the daily work

that caregivers do, oftentimes also instilling practices of resistance and critical hope among care workers. At the same time, the communities created by care activism help migrant caregivers survive and even thrive in the face of arduous working and living conditions and the pains surrounding family separation.







In Japan's Nuclear Disaster and the Politics of Safety Governance, Florentine Koppenborg argues that the regulatory reforms taken up in the wake of the Fukushima disaster on March 11, 2011, directly and indirectly raised the costs of nuclear power in Japan. The Nuclear Regulation Authority resisted capture by the nuclear industry and fundamentally altered the environment for nuclear policy implementation. Independent safety regulation changed state-business relations in the nuclear power domain from regulatory capture to top-down safety regulation, which

raised technical safety costs for electric utilities. Furthermore, the safety agency's extended emergency preparedness regulations expanded the allegorical backyard of NIMBY demonstrations. Antinuclear protests, mainly lawsuits challenging restarts, incurred additional social acceptance costs. Increasing costs undermined pronuclear actors' ability to implement nuclear power policy and caused a rift inside the "nuclear village." Small nuclear safety administration reforms were, in fact, game changers for nuclear power politics in Japan.





What Women Want analyzes decades of voting preferences, values, and policy preferences to debunk some of the media and academic myths about gender gaps in voting and policy preferences. Findings show that no single theory explains when differences in women's and men's voting preferences emerge, when they do not, or when changes - or the lack thereof - occur over time. Steel extends existing theories to create a broader framework for thinking about gender and voting behavior to provide more analytical purchase in understanding

gender and its varying effects on individual voters' preferences. She incorporates the long-term effects of party identification and class politics on political decision-making, particularly in how they influence preferences on social provision and on expectations of the state. She also points to the importance of symbolic politics.



Despite new superpower pressures, the region is moving towards a multi-polar order, with greater agency for Southeast Asian countries. The key to Southeast Asia's future may be other external powers - particularly Japan, Australia, India, and Europe - who can provide ASEAN governments with more diverse partnerships, enabling them to avoid the bipolar blocs of superpower

rivalries. The book argues that external partners are helping to shape the geopolitical order by supporting ASEAN leadership and diluting the influence of great powers.



As the United States transformed into an industrial superpower, American socialists faced the vexing question of how to approach race. Lorenzo Costaguta balances intellectual and institutional history to illuminate the clash between two major points of view. On one side, some believed labor should accept and apply the ascendant tenets of scientific theories of race. But others stood with International Workingmen's

Association leaders J. P. McDonnell and F. A. Sorge in rejecting the idea that racial and ethnic division influenced worker-employer relations, arguing instead that class played the preeminent role. Costaguta charts the socialist movement's journey through the conflict and down a path that ultimately abandoned scientific racism in favor of an internationalist class-focused American socialism.



The New Age of Naval Power in the Indo-Pacific provides an original framework in which five "factors of influence" explain how and why naval power matters in this pivotal part of the world. An international group of contributors make the case that these five factors draw upon a longstanding influence of naval power on regional dynamics and impact the extent to which different states in the region use naval power: the capacity to exert control over sea-lanes, the capacity to deploy a nuclear deterrent at sea, the capacity to implement the law of the sea in an advantageous way, the ability to control marine resources, and the capacity for technological innovation.

There is clearly a positive fascination: various bestsellers entitled Talmud are found in vending machines and public schools, while private 'Jewish education' institutions have opened across South Korea, claiming to improve children's IQ. People can stay at the Talmud Business Hotel in Taiwan, or attend Chinese centres for Jewish Studies with academics who have never met a Jew. There is a legend that Japanese people are a Lost Tribe of Israel, and 'Anne's day', named after Anne Frank, is a euphemism for menstruation. Yet the region also shows

some of the world's highest rates of antisemitism, manifesting in disturbing ways: Taiwan's concentration camp-themed restaurant, or South Korea's 'Adolf Hitler Techno Bar & Cocktail Show'.
