The Jesuits were a major source of European information on Japan from the late 16th to early 17th century. Not only were they active missionaries but they also produced linguistic, religious and cultural tracts, regional chronicles, as well as hundreds of Latin plays written in imitation of classical Greco-Roman theatre but set in Japan. An intriguing yet underexplored segment of Jesuit school theatre is that which stages non-classical, non-Western subjects such as Japan, and this volume is the first to present Latin texts of two of these plays alongside full English translations, commentaries and an extensive introduction.

While no anthology can comprehensively represent queer Japanese literature, these selections nonetheless expand our understanding of queerness in Japanese culture.



In Bracketing Paradox and Direct Compositionality: Montagovian Morphology for Bound Morphemes, Kazuhiko Fukushima resolves bracketing paradoxes in Japanese - morphological vs. semantic incongruity, which supposedly pose insurmountable obstacles to traditional and simple-minded morphology - within morphology (the lexicon) proper. This resolution is achieved through formal semantic apparatus developed by Richard Montague and his followers, hence the label Montagovian Morphology. More generally and theoretically, this book


addresses the issue of the optimal interface between morphology, which deals with minimal units of meaning and their combination within a word, and semantics, which handles increasingly larger units of meaning in the sentence.

This book provides rare insights into motivation among extremely successful learners of English and languages other than English (LOTEs) through the analysis of a longitudinal study and the examination of the factors involved in becoming multilingual in a non-multilingual environment. Based on sixteen interview sessions, conducted over the course of nine years while the learners progressed from high school to the world of work, this book offers the story of how two learners persist in English/LOTE learning. The study illuminates the long-term

processes through which the interviewees develop ideal English/LOTE selves in an environment where multilingualism is not emphasized and where both English and LOTEs can still be described as foreign languages.

This book offers an analysis of translations in Japanese and Korean of *Harry Potter and the Philosopher's Stone* and *The Hobbit, or There* and Back Again to show how the translated versions crystallise the translators' interpretations of relationships in the way characters address one another. This book discusses fan translations of Korean and Japanese to English of various popular media, observing that the emotional meanings easily lost when translating in this direction are often deemed important enough to warrant the insertion of additional explanatory material.

Ozu Yasujiro's moving family drama, *Tokyo monogatari/Tokyo Story* (1953), is universally acknowledged as one of the most significant Japanese films ever made, and regularly cited as one of the greatest films of all time in polls of leading critics and filmmakers around the world. Alastair Phillips combines a close analysis of the film and its key locations - the city of Tokyo, the town of Onomichi and the coastal resort of Atami - with a discussion of its representation of Japanese society at a time of great cultural change. Drawing upon Japanese and

English language sources, he situates the film within various contemporary critical and industrial contexts and examines the multiple international dimensions of Tokyo Story's long after-life to understand its enormous contribution to global film culture.

Dr Hughes' academic output from the 1970s to the present has covered many aspects of Japanese traditional music-making, in particular the min'yō (folk song) genre of which he remains the primary scholar outside Japan. His groundbreaking work has also encompassed theories of musical grammars, oral notation systems

in cross-cultural perspective, as well as several papers on cultural heritage and preservation societies. The contributors to this volume comprise many of David's former students, as well as scholars from Japan and elsewhere with whom Dr Hughes has collaborated over the years. The papers reflect the depth and breadth of Hughes' research output, demonstrating his continuing influence over ethnomusicologists around the world.





In Anarchy of the Body, art historian KuroDalaiJee (a.k.a. Kuroda Raiji) sheds light on vital pieces of postwar Japanese avant-garde history by contextualizing the social, cultural, and political trajectories of artists across Japan in the 1960s. A culmination of years of research, Anarchy of the Body draws on

an extensive breadth of source material to reveal how the practice of performance by individual artists and art groups during this period formed a legacy of resistance against institutionalization, both within the art world and more broadly in Japanese society. This book contains 256 high-quality reproductions, including rare performance photographs not readily accessible elsewhere, as well as a comprehensive chronology. KuroDalaiJee was awarded the 2010 Ministry of Education Award for Fine Arts (criticism category) for his work on this volume.


Shinto shrines became one of the most visible symbols of Japanese imperialism in the early 20th century. From 1868 to 1945, shrines were constructed by both the government and Japanese migrants across the Asia-Pacific region, from Sakhalin to Taiwan, and from China to the Americas. Drawing on theories about the constructed nature of the modern categories of 'religion' and the 'secular', this book argues that modern Shinto shrines were largely conceived and treated as secular sites within a newly invented Japanese secularism, and that they played an important role in communicating changed conceptions of space, time and ethics in imperial subjects.

It has been a decade since people across the Arab world rose up in revolt against their governments in 2010/11, demanding political empowerment, social reform and economic improvement. Pro-democracy protests, as they were called in common parlance, which spread rapidly through the mobilisation of social media calls, ended up overthrowing long-standing authoritarian regimes in Tunisia, Egypt, Yemen and Libya. That gave rise to hope for a more representative future, as well as economic reforms, after decades of mismanagement and

stagnation. However, such hopes were quickly dispelled, as the political vacuum created by the elimination of regional dictatorships deepened fractures in many of these societies along ethnic, religious and tribal fault lines.




Awaiting MacArthur's Return is the first comprehensive comparative analysis of the major World War II guerrilla groups across the Philippine Archipelago, providing a fuller picture of the nature of the war in the Southwest Pacific and revealing the extent to which the guerrilla movement affected operations for both Allied and Imperial Japanese forces. Analyzing the organizational effectiveness of the guerrillas

resisting the Japanese occupation of the Philippines, this book alternates narrative chapters with thematic chapters examining the guerrillas' organization, logistics, administration, intelligence-gathering, and the support they received from Allied forces and provided the Allies in turn. Villanueva offers the most in-depth analysis of the guerrillas' military organization and effectiveness in the context of existing theories of insurgency and counterinsurgency while using an extensive body of memoirs, archival guerrilla and US Army and Navy records, and translations of Japanese documents and interviews with Japanese officers.

Drawing on important works from Japan's past, players must advise the emperor on how to proceed. Will they call for a "strike south" to seize the natural resources of Southeast Asia - even at the risk of war with Great Britain and the United States? Or will they seek an understanding with those nations—even if it means giving up the ideal of a Pan-Asian partnership?

In *Imperial Gateway*, Seiji Shirane explores the political, social, and economic significance of colonial Taiwan in the southern expansion of Japan's empire from 1895 to the end of World War II. Challenging understandings of empire that focus on bilateral relations between metropole and colonial periphery, Shirane uncovers a half century of dynamic relations between Japan, Taiwan, China, and Western regional

powers. Japanese officials in Taiwan did not simply take orders from Tokyo; rather, they often pursued their own expansionist ambitions in South China and Southeast Asia. When outright conquest was not possible, they promoted alternative strategies, including naturalizing resident Chinese as overseas Taiwanese subjects, extending colonial police networks, and deploying tens of thousands of Taiwanese to war.







'Subaltern studies' refers to the importance of 'subordinate' groups in the making of history. The latter are usually defined as encompassing the urban and rural underclasses, the majority in any society, although generally the term is said to refer to all non-elites, including women. Most often the discourse concentrates on instances of social protest as points whereat the 'subalterns' make their 'voices' heard in response

to, or even independent of, manipulations by the elite. The book draws on wide-ranging sources to be explored for direct and indirect access to these voices, and include elite Persian diplomatic and political-economic (court-level) materials but also those drawn from such a broad range of 'cultural' spheres as, for example, art and architecture (including cinema, for the modern period), prose, poetry and other media and religious materials (Sunni, Shi'i and Sufi) of all genres in all relevant languages.


